From the President's pen: Volunteers: beacons of light

I recently happened upon a delightful interview on ABC radio with Professor Glenn Mitchell, Convener of the History Program at the University of Wollongong. He spoke passionately of the role that

individual and groups have had, and continue to have, in the development of society. He spoke of philanthropists, motivated by deep desire to reach the heart of humanity that cannot be found in material wealth; he spoke of the nobility of the Australian welfare system, that has emerged in a manner that recognises a need for a level of equality in the community, and serves to ensure that the welfare of all, regardless of personal circumstance, will be protected, and that strives to ensure the dignity of all.

Last weekend, I attended a workshop that touched briefly on the volunteers of L'Arche, an international movement that provides housing and domestic support and friendship for handicapped persons. Persons with profound disability are provided with the chance to live in community, built upon the generosity of volunteers who live with them, and tend to their needs around the clock; Remarkably selfless, and a powerful beacon of hope in our society. Need, in its often disfigured form of poverty, of disability, of darkness of mind, is not only ameliorated, but held close to the heart, and given purpose.

Volunteers or philanthropists, motivated by love or faith, principled in the values of equity and justice: you provide the signposts of modern society.

The endeavours that reach to the far ends of the earth, that seek to provide light to those in dark corners, that give attention to some who have found themselves - with their lives in constant flux - in search of a home: these actions cannot be understated for their purpose. When we reach to the margins of society, we create the very heart of society.

It gives me cause to dwell on the many who have given tirelessly in the work of settling refugee families into our community. I continue to be moved by the extraordinary generosity of those who step forth to assist. The task is frequently not an easy one. Family settlement, for example, requires deep commitment "day in, and day out - perhaps for weeks or months" leading the hands of these new "friends", sisters and brothers on another journey, who have shown the courage to put their hand forth in seeking help. I am moved by those who offer the generosity of financial assistance, who state their commitment to be one with those who arrive with their all material belongings in just a couple of bags.

It is these that epitomise our efforts, and ensure the success of the transition of the refugee to ultimately call our community their home. And it is much more. They build our community; form the fabric of our society. So often unsung in their efforts, yet they are the chorus of hope. Our future as an organization will depend on you who support in such a way. And indeed, the ability for us to continue to reach to communities across the world, and the ability for us to shape our own community is contingent upon your efforts.

As we journey toward these dreams, may I encourage the continued spirit of generosity, and offer gratitude for the inspiration that prevails in every effort of support.

Want to do something for the environment and support Sanctuary at the same time?

Russell Trebilcock, our Vice President, is also an accredited Home Sustainability Assessor, authorised by the Government to conduct an assessment of local residences to determine how energy efficient they are and to identify what can be done to improve their sustainability.

These Home Sustainability Assessments (HSAs) are available free of charge to anyone; a home owner or a tenant. The householder will receive a sustainability report (about 4-6 weeks after the HSA) that identifies ways they can improve their energy efficiency.

Even though recent announcements from the Government have removed the options of accessing a Green Loan through the scheme, the free assessment offer is still available. If you just want to find out how efficient your house is and how you can improve, then an HSA will help.

Russell is offering to donate to Sanctuary \$10 of the fee he is paid for every HSA he does for someone who books it as a result of this article or for some one who asks that the donation to Sanctuary be made when they book their HSA.

An HSA will take approximately 1% hours and at least one of the principal householders will need to be present to answer questions about your energy usage.

Admin Officer News:

Congratulations Cherie, who has recently been appointed as the Volunteer Coordinator with the Byron Community Centre. While this will obviously impact on Cherie's availability for Sanctuary, the appointment also has some spin-off benefits for us. At Byron, Cherie is responsible for developing processes and procedures, training, recruiting, rewarding, rostering etc all associated with volunteering. We've no doubt she'll pass on the information she

creates and acquires at Byron for Sanctuary to draw on.

Cherie has commenced working three days a week in Byron and will continue with Sanctuary one day (Thursday) per week in the office at the Lismore Neighbourhood Centre.

Introducing Phil Veness North Coast Settlement Services Outreach Worker

As most members are probably aware, Sanctuary Northern Rivers has been the primary sponsor and settlement agency for the majority of the African Lismore community. It is our role, in partnership with Anglicare to provide assistance to new arrivals for at least six months into their settlement.

After six months, the main agency of support for the refugee community is the North Coast Settlement Service run by St Vincent De Paul Society. We are privileged to have Phil Veness in the position of outreach worker and very fortunate that he is in fact is based in Lismore. I have asked Phil to write a few words about himself and his position so that Sanctuary members can be more aware of what services exits for the refugees settling here.

My name is Phillip (Phil) Veness, and I grew up in a small town, Manilla, just over the mountains. My education background includes: Secondary Social Science and Special Education Teaching at Armidale Teacher's College, a Grad Dip in Ed Studies/Aboriginal Ed, and a Masters focusing on Education and Development in Developing Countries.

I taught in country schools for eight years before becoming the NSW Education Department's Aboriginal Community Liaison/
Education Officer. Later, as a teacher at Dulwich High School in Sydney, I worked with young people from many new and
emerging communities, including refugees from Asia, the Middle East, Africa and South America. During this time I learnt about
issues concerning new arrivals in Australia and the value/need to develop effective programs for young people. Such programs
empower young people to positively influence the successful settlement of their families into their new community, and allow them
broad ranging opportunities for the future.

After serving as Deputy Principal of a Pitjantjatjara Secondary College in Central Australia, I worked in JobNetwork as an Employment Consultant, Trainer and Training manager in remote Australian communities.

A strong sense of inclusion and social justice has motivated me in all of my professional and personal life.

I recently began work with St Vincent de Paul Society as Outreach Worker for North Coast Settlement Services, funded through the Settlement Grants Program (SGP) of the Department of Immigration and Citizenship. The SGP focuses on:

- 1. Orientation assisting people to become more self-reliant and able to participate in Australian society.
- 2. Developing Communities assisting new and emerging communities to identify common goals and interests, develop a shared purpose and promote a sense of identity and belonging.
- 3. Integration: Inclusion and Participation assisting new arrivals to interact with and understand the broader Australian community and encourage the wider community to be more responsive to new arrivals.

I work in Lismore on Monday, Tuesday and Friday from the Diocesan Office of SVdP (above Vinnies in Magellan Street); Wednesday in Ballina (Vinnies, Martin Street); and Thursday in South Tweed Heads (Vinnies, Industry Drive).

I am happy to speak with anyone about any aspects of the programs.

Subject: Caring for unaccompanied refugee minors

Dear friends,

I am sending you this in the hope that you will consider it, and forward it on to your networks of people who might be interested!

You may know that recently a large number of asylum seekers have arrived on Christmas Island. Of these, many are unaccompanied children - mostly boys from Afghanistan who have been sent away from their families as they reach adolescence (therefore 'fighting age', and they become of interest to the Taliban).

The Department of Immigration and the Department of Human Services are DESPERATE to hear from people who may be able to accommodate these boys when they receive their visas. If they don't have a home to go to, they basically stay in detention, or in public group housing (not ideal!).

I am soon to become the 'carer' (not legal guardian) of a 14 year old Afghan boy I met in a jail in Jakarta who made it to Christmas Island. I have been in close contact with DHS and have been amazed at the level of support they offer, both financially and in every other way, to people entering into a carer arrangement.

The timeframe is flexible / negotiable - generally until the child either turns 18 or their parents arrive in Australia. Parental applications under the 'split family' provisions are being prioritised to ensure that these children are reunited with their families as soon as possible. A reasonable timeframe for that to happen is around 18 months, but there are no guarantees.

Contact me if you wish to speak with the relevant person at DHS - she is lovely and very keen to hear from people.
